April 2016 Regular Council Meeting - Yes, minutes stands as approved.

#### 3. Administrative Reports

#### Senior Vice President & Provost (Jonathan Wickert)

- Library was open 24/7 during dead week and finals week for the first time. This is making the library more student-focused. This has been a huge success.
- Graduate commencement is Thursday, May 5 and undergraduate commencement is Saturday, May 7. If the weather cooperates undergraduate commencement will be held at Jack Trice Stadium for the first time. The back-up location is Hilton with overflow in Cy Stevens.
- Board of Regents (BOR) Legislature is giving ISU a ¼ of what was asked for; 5 years of increases to state appropriations which is unusual. BOR will discuss additional tuition increases for fall 2016 semester (above what they have already approved earlier in the year). June 9 will be first BOR discussions and then another meeting via phone will take place to discuss and approve.
- New College of Human Sciences Dean, Laura Dunn Jolly will start July 5 (<u>Inside Iowa State article</u>).
- Congratulated Council on moving forward on several initiatives this year and thanked Tera for her leadership.

#### Vice President, University Human Resources (Stephanie Downs for Julie Nuter)

- Stephanie shared the <u>ISU Wellbeing</u> website. The website is full of resources, including quick links. Staff are encouraged to check it out.
- UHR currently does offer performance management training for supervisors/managers through Learn@ISU. This training provides high level guidance and tools to conduct performance evaluations. People can follow the <a href="link">link</a>, click on "Catalogs", and search the catalog for "P&S Performance Management Training". In the event that we develop a new performance evaluation system, we would need more in-depth/detailed training than what is currently offered.

#### Faculty Senate (Jonathan Sturm)

- Faculty Senate continues to look at enrollment management. A report will be sent to President Leath by end of May/early June. P&S employees are encouraged to share their thoughts on enrollment management. The feedback collected by the executive committee will be shared with faculty senate before their report is submitted.
- The Faculty Conference, *Ethical Research in the Age of Open Access*, was held on April 26 in the Memorial Union. Faculty will be able to provide practical applications of what was learned during the conference.
- One focus area for the Faculty Senate will be to increase awareness of open access of research; in the beginning will look at funding and collaboration with various departments.
- Diversity and Inclusion is also at the forefront of Faculty Senate; looking at training options and focusing on making sure ISU offers an inclusive campus environment.

## Senior Vice President, Student Affairs (Martino Harmon) Priorities:

- Short term priorities -listening to all departments within the division of student affairs, filling several vacant positions, going around to different departments on campus to listen and understand their needs, and looking at structure of Student Affairs cabinet, moving towards a cluster model with teams, this will help with being more responsive.
- Long term priorities 1) Focus on health/wellness of students (this is currently a gap area), 2) Employer wellbeing, 3) Enrollment management, 4) Student success, 5) Space (most complicated priority, needs short-term solutions and long-term visioning), 6) Diversity/Inclusion

#### Vice President, Diversity & Inclusion (Reginald Stewart)

- Need to take care of some functional items staff structure, hiring, space, etc.
- Meeting many people on campus to understand campus climate
- Serves two functions Vice President of Diversity & Inclusion forward thinker and Chief Diversity Officer compliance, functional role
- Role is to challenge the status quo have to ask hard questions
- Diversity/Inclusion not a problem to be solved instead trying to improve ISU and diversity/inclusion is just one of the tools
- Three data points being reviewed <u>Diversity Audit and Asset Inventory</u>, <u>2014</u>, Status of Women report, and Higher Education Accreditation report
- Correct term to use is Under Represented instead of Minority
- Creating a Rapid Response Team develop institutional response, work in partnership with Student Affairs
- Not just working on campus, networking with Ames PD, Mary Greeley, Leadership Ames, etc.

#### **P&S Council Executive Committee Reports**

#### President (Tera Lawson)

Good afternoon everyone! It has been another exciting and busy month for Council and this month looks to be pretty busy as well!

On April 21st, I presented a statement to the Iowa Board of Regents, on behalf of the Iowa State University Professional and Scientific Employees. I have shared that statement, in its entirety, with you via Special Report to Council 16SP03 and, as a Special Report to Council; it has also been included in the Council Docket, which can be found on the Meetings Page of the Council Website.

• The opportunity to present a statement to the Iowa Board of Regents is provided to Council each year and one that we greatly value as it provides us with a platform to highlight the impact and contributions of Professional and Scientific Employees on our institution and I hope that we were effective in doing that again this year.

We also received the response to Council Motion FY16.7 Seeking Clarification regarding interpretation and application of the Flexible Hours Program, Flex Time Policy, and Vacation Leave Policy during and Iowa State University partial closing!

- I shared the response with each of you with a request for review and for feedback, concerns, and questions and we want to let you know that we greatly appreciate the comments and suggestions that we received!
- The comments and suggestions have been compiled and are currently being reviewed. Once the
  Policies and Procedures Committee has had a chance to meet they will help us to determine
  what our next steps will be.

A portion of our April Executive Committee Meeting was dedicated to the discussion of the proposed salary recommendations and benefits information.

The Executive Committee was joined by the Compensation and Benefits Committee as well as
Julie Nuter and Emma Houghton for the discussion and the information that was provided, while
it was via preliminary reports for discussion purposes only, served to inform the FY 2017
Compensation Recommendation that the Compensation and Benefits Committee is bringing
forward for a first read today.

I would also like to remind each of you that comments on the draft Iowa State University Strategic Plan are being accepted through the online comment form on the Strategic Planning Website through May 10th. If you haven't submitted your feedback yet, you have until Tuesday!

- This is document that will guide lowa State University in to the year 2022 and this is YOUR
  opportunity to provide feedback, concerns, and questions to the Strategic Planning Steering
  Committee.
- The final reports from each of the six Strategic Planning Subcommittees: Student Experience, Research Profile, Economic Development and Service to Iowa, Campus Environment, Infrastructure Enablers, and Additional Creative Opportunities are also available on the strategic plan development website.

I would also like to provide you with brief updates on the Administrative Searches that are currently underway.

- The Search Committee for the University Counsel position, on which I am serving as a representative of the Iowa State University Professional and Scientific Employees, has successfully brought three candidates to campus for interviews.
  - Feedback forms have been collected and are currently being reviewed. This process has moved quickly thus far and I expect that the rapid pace will continue as we continue to move forward.
- The Search for the Senior Vice President of University Services is also moving forward at a rapid pace and we are planning to have candidates on-campus next week.
  - O I am also serving on this search committee as a representative of the Iowa State University Professional and Scientific Employees. Additionally, members of the Professional and Scientific Council Executive Committee, Faculty Senate Executive Committee, and Student Government will be participating in a portion of the on-campus interviews each of the candidates.

The presentations from the *Ethical Research in the Age of Open Access* Conference that was hosted by Faculty Senate held on April 26<sup>th</sup> were recorded and will be available on the Faculty Senate Website soon.

• I have asked Jonathan Sturm, the New Faculty Senate President, to notify exec when they have been posted and we will get that information out to the Professional and Scientific Employees, likely via our monthly newsletter.

An e-mail survey will be sent out to all returning and new Councilors tomorrow requesting that you enter your name and rank your top three preferences for FY 2017 Professional and Scientific Council Committee Appointments.

- You may also indicate, via question 3, if you are interested in serving as a Committee Chair. If you are interested in serving as a Committee Chair we are asking that you provide a statement about why you are interested in serving as the Committee Chair.
- We will be asking for a pretty quick turn around on these so that the committee assignments can be made prior to the May 26<sup>th</sup> Meeting.

## Peer Advocacy (Ben Green)

- Also, we have continued to make progress on mentoring and plan to share our materials with the Executive Committee in May.

#### Policies and Procedures (Kris Koerner)

- Tera requested Council's feedback on the Holiday, Vacation, Flex Time and University Break Guidelines/Policy updates. The deadline for feedback was May 4th at noon. A compiled report of this feedback will go to the Policies & Procedures Committee for their review. Our Committee will work with the Executive Committee to pull together some type of response back to UHR.
- Our Committee is also reviewing some updates to the Facilities and Grounds Use, Activities Policy as it applies to Designated Public Forums (previously referred to as Free Speech Zone). Whitney Grote is a member of that work group. Updates are merely clarifications and do not change any requirements or meaning. Our Committee will be reviewing and providing Whitney with any feedback. These updates will likely be in place by July 1st. The other changes to the Facilities and Grounds Use, Activities Policy has to do with the Unmanned Aircraft Systems (drones) addition. More work was done on this section to provide further clarification. P&S Council endorsed the original changes back in November 2015.
