#### 3. Administrative Reports

#### Senior Vice President & Provost (Jonathan Wickert)

- Showcased the College of Veterinary Medicine since Council was meeting out at <u>Vet Med</u> for the first time.
- Next capitol campaign project new standalone building for Diagnostic Laboratory (120 million) at the Vet Med College.
- Spring Commencement held at Jack Trice Stadium for the first time. It was very successful!
- 50-60 people from ISU attended the NSCORE conference students, staff, and faculty.
- Board of Regents (<u>BOR</u>) June 8-9: will discuss the proposal of mid-cycle tuition increase, will
  have a second meeting in July for final approval, presentation by Student Affairs on CoCurricular Transcript (two parts, what ISU tracks and other experiences that the student will
  self-report).
- Expect to have 36 million in new revenue (2.2 million from increase in state appropriations); salary policy includes an average 3.5% compensation increase for employees.
- Reorganization of Central IT services, impacted 23 positions from multiple areas within ITS. First time looking at IT services in 10 years. It was a thoughtful process developed over a period of time. Several new IT positions will be created with this reorganization.

## Vice President, University Human Resources (Julie Nuter and Emma Houghton) Slides included with minutes

- FY17 Annual Salary Adjustment Parameters and updated 2016-2017 Salary Matrix on Classification and Compensation website.
- May 18 new regulation came out from federal government (a mandated change in the Fair Labor Standards Act will raise the salary threshold for individuals who qualify for overtime pay, from about \$23,000 to \$47,476). This will go into effect December 1. It is business as usual right now. See <u>Inside Iowa State</u> article.
- Professional and Scientific Classification/Compensation System UHR is looking at how we define our jobs, how we categorize them, policies/procedures that support pay administration for sustainability, and will set the system up to be market based, focused on performance, and ensure internal equity. UHR will hire a consultant to assist with this major undertaking, have talked with five different vendors. UHR will also create a steering committee to make this happen so there is good participation from the University community, including Professional and Scientific Council. This is about attraction, retention and reward makes sense to do this.

#### 4. P&S Council Executive Committee Reports

#### President (Tera Lawson)

Good afternoon everyone!

At every meeting this year I have used my President's Report to tell you about the exciting things that have kept Council busy during the previous month, but as this is the last President's Report that I will give as your Council President I thought we'd change it up a bit and instead reflect on the very busy and exciting YEAR the Professional and Scientific Council has had!

I shared the first Special Report to Council with all of you during our October meeting as a way to record, share, and archive information as Council works to resolve issues, find additional information, and to share information with not only Council, but all Professional and Scientific Employees.

I will be sharing the fourth Special Report to Council which is titled the 2015-2016 Professional and Scientific Council Year End Report with you as an attachment to the meeting minutes. I have asked Jessica to pull up the document for us so that you can see the things that we have accomplished this year. Please note that the document is 12 pages long and while some of that is due to the use of tables and the inclusion of brief descriptions we really have accomplished a lot this year!

The document has been organized into seven priority areas. Six of these are from the 2015-2016 priority planning session we engaged in as a Council during our meeting on July 9, 2015. The ideas, suggestions, and comments provided by Councilors during that meeting were kept in their original words, but grouped by the Executive Committee, during the Executive Committee Retreat on July 30th, into six priority areas including: Benefits/Services to Employees, Professional/Personal Development, Compensation, Collaboration, Communication, and Professional and Scientific Employee Networking. As a Council we worked to address these 2015-2016 priorities in addition to, or in conjunction with, the Council Priorities of: Serving as the Voice of P&S Employees in the Shared Governance Structure, Investigating and Responding to P&S Employee Concerns, Providing Professional Development Opportunities for P&S Employees, Honoring P&S Employees, Representing P&S Employees, and Encouraging P&S Employee Engagement.

This Special Report to Council includes the progress we've made on each of these priorities in 2015-2016 and includes things that can be found in the Council Docket, that came to Council in the form of a motion or a Special Report to Council, as well as things that have been happening less publically like the creation of a Learn@ISU section for opportunities offered by Council, the development of Councilor surveys, our efforts to increase collaboration with Faculty Senate and our counterparts at the other regent institutions, our efforts to be more mindful of and plan for the involvement of our colleagues who work off-campus, and our efforts to encourage P&S Employee Engagement.

We as a Council addressed timely issues as well as long standing ones, we looked at old problems in new ways, we did our research, we made great strides toward increasing the visibility of Professional and Scientific Employees at our University, we represented our constituents and made our collective voice heard, and we helped to improve the lives of Professional and Scientific Employees at our University!

We have definitely had a busy and exciting year and I want to thank each of you for your contributions and efforts, it has been a pleasure serving as your President, and I look forward to continuing our work in the upcoming year!

#### Secretary (Kate Goudy-Haht)

Since this is the second meeting in May, there is no new update on expenditures. All funds are allocated through the end of the year for Council related activities. A report will be submitted at the end of the fiscal year outlining Council expenses.

#### VP for University Community Relations (Jessica Bell)

I attended the May 17th New Employee Orientation and spoke with 13 new Professional & Scientific Employees about Council as well as advertising the upcoming seminar series with Julia Nuter in July. I've also been working with the upcoming VP of University Community Relations Ben Green to ensure he has access to continue the new employee lists we have started, as well as transferring other knowledge and documentation for the position

#### Awards (Diane Rupp)

- Yearly recap of awards: 21 Professional and Scientific Council Awards, 14 individual CYtation, 5 team CYtation, as well as the Dan Woodin award and the inaugural Outstanding New Councilor Award. In total, 48 nominations were reviewed in 2015 compared to 28 in 2014. Obviously everyone did a great job promoting these very special awards.
- This year we also evaluated 29 nominations and forwarded 12 suggestions in conjunction with 4 University P&S Level Awards to the Provost's Office. That awards ceremony with take place in the fall.
- The awards committee will also continue to contribute to staff spotlights in the Professional and Scientific Council Newsletters.

#### Compensation & Benefits (Karl Schindel)

Your Compensation and Benefits committee met twice between the last meeting and today. We focused on the Compensation and Recommendation motion in our earlier meeting, and today we welcomed our new committee members and talked about how our committee works. In addition, as Chair I attended three benefits vendor reviews in the last week. There are three more next week.

#### Peer Advocacy (Ben Green)

- As a follow up to the motion passed last month regarding improvements to lactation spaces and
  policies, our proposal was sent to university administration including University Human
  Resources. We heard back right away that they received the proposal and will study this topic.
  Additionally, two groups have sent a letter supporting the proposal to both Professional and
  Scientific Council and University Human Resources. Those letters were from the Iowa State
  University Postdoctoral Association and the Work/Life Advisory Committee.
- Also, last month our committee met with the Professional and Scientific Council of the College
  of Design. We shared information about our committee and their members had some great ideas
  for ways our committee can serve Professional and Scientific staff. Their ideas have been added
  to our list of objectives for next year.

#### Policies and Procedures (Kris Koerner)

- Policies and Procedures met on May 17th to discuss the feedback received from Council on the
  vacation and flex policy changes and new supporting Guidelines document from UHR. This was
  in response to the motion the Executive Committee brought forward in January's Council
  meeting. Our committee wrote up a draft response with recommendations for further
  clarifications and suggestions that was discussed at the May 19th Executive Committee Meeting.
  A few changes were made and the response was sent to Council with the May 26th Council
  meeting agenda.
